ANC 5E Resolution requesting District Department of Transportation installs Capital Bikeshare stations

WHEREAS the District Department of Transportation (DDOT) manages the Capital Bikeshare system in the District of Columbia,

WHEREAS Edgewood is a densely populated neighborhood that is within biking distance of downtown DC, several metro stations, and other popular locations,

WHEREAS there are large apartment buildings, condo buildings, single family housing as well as the Edgewood Recreation center located near the intersection of Franklin Street NE and 4th Street NE,

WHEREAS the newly completed pedestrian bridge from the Rhode Island Avenue metro station and the Metropolitan Branch Trail allows for increased use of both transportation amenities,

WHEREAS the Capital Bikeshare program would increase transportation options for Edgewood residents, while reducing car dependency, traffic, and pollution in these communities and citywide,

THEREFORE, BE IT RESOLVED that ANC 5E supports the Capital Bikeshare program, and requests that the Department of Transportation include these Edgewood stations in the Capital Bikeshare network.


Metropolitaton Branch Trail next to new pedestrian bridge
