Whereas, Metroball provides mentoring, tutoring, and scholarship opportunities for youth in the ANC5E constituent area; and



Whereas, the D.C. Department of Parks and Recreation (DPR) provides space for the tournament at the New York Avenue Playground (the facilities); and


Whereas, the residents of SMD 5E05, by consensus, support the tournament; and
