
This letter is to advise you of action taken by Advisory Neighborhood Commission ANC 5E to support the SiriusXM Satellite Radio BZA Application #19354 for Special Exception, pursuant to Subtitle C S 1304.2, to relocate three existing receive-only antennas that will exceed the mounted height limit of twelve feet above the roof, per Subtitle C S 1304.1(b), at 1500 Eckington Place NE, Square 3518, Lots 29 and 30.

We understand that the antennas will not exceed 17 feet in height. We also understand that the antennas setback on the roof will not exceed five feet.

At a duly noticed public meeting on September 20, 2016, with 8 of 10 Commissioners present, six or more constituting a quorum, following a presentation by the applicant, the ANC 5E voted to support the requested application #19354. The Eckington Civic Association, during its public monthly meeting on September 12, 2016, also voted unanimously to support the SiriusXM Satellite Radio BZA special exception application #19354.

As such, ANC 5E hereby confirms its support for the requested special exception and recommends that the applicant's request be approved.
